Tim Rudd declared the polls open and currently there were no problems.

**REVIEW OF ABSENTEE BALLOTS FOR WRITE-IN CANDIDATES, DOUBLE BUBBLE AND OVER VOTES:**

Director Miller advised the Board of the absentee ballots that require Board review.

The Board went off the Record to review those ballots containing write-in candidates, double bubble and over votes.

The Board went back on the Record

**2010-128** – Dave Lane made the motion to duplicate to the correct precinct the absentee ballots that the staff determined had received a ballot from the wrong precinct. Rick Combs seconded the motion. Upon roll call, all Members voted “yes”.

**2010-129** – Dave Lane made the motion to not count, per the ORC and Directive from the Secretary of State, the absentee ballot that was returned without a stub. Rick Combs seconded the motion. Upon roll call, all Members voted “yes”.

The Board went off the Record to review the double bubble absentee ballots.

The Board went back on the Record.

**2010-130** – Dave Lane made the motion to duplicate the “double bubble” absentee ballot for the candidate that was indicated and to ignore any blank write-ins. Rick Combs seconded the motion. Upon roll call, all Members voted “yes”.

The Board went off the Record to review ballots.

The Board went back on the Record.

The Board reviewed and counted (per Directive 2010-72) the valid write-in votes even though the oval for the write-in was not darkened.

The Board will stay in Session but stands in Recess until 3:00 p.m. unless otherwise notified.

At 6:00 p.m. the Board went back in Session to review ballots. The Board reviewed the over votes that needed to be duplicated and tallied the write-in votes.

Precincts that contained Election Day ballots in the M100 Emergency Slot were: BAV-C, BAT-A, MI-E, ME-F, PE-C, SK-C, SK-G, UN-X, UN-F1F and WGT-C.

The Accuracy Board (Connie Bare (R), Gregg Conrad (R), Denise Kelly (R) and Sandy Zimmer (D)) met and found the Test Results to match.

**2010-131** – Dave Lane made the motion to accept the Unofficial Results of the November 2, 2010 General Election. Rick Combs seconded the motion. Upon roll call, all Members voted “yes”.

The Board commended the Director, Deputy Director and staff of the Board of Elections on a very smooth Election.

The Board authorized the usual practice and left it to the Director and Deputy Director the half day staffing for the day after the election.




