All of the following offices will be electing a Democrat and Republican Candidate (and any filings for Minor Party Candidates) at the Primary Election to be held on **Tuesday, March 6, 2012** (with the exception of the President and US Representative to Congress). ALL Petitions to run in the Party Primaries must be filed with the Board of Elections not later than Wednesday, **December 7, 2011 by 4:00 p.m.**

Write-In Candidates for the **Primary Election** for the following office must file with the Board of Elections by **Monday, December 26, 2011 by 4:00 p.m.**

Independent Candidates for the following offices (other than President and Vice President) must file Petitions not later than **Monday, March 5, 2012 by 4:00 p.m.**

The winning party candidates from the Primary Election as well as any "Certified" Independent Candidates will appear on the General Election Ballot on November 6, 2012.

Write-In Candidates for the **General Election** must file a Declaration of Intent by **Monday, August 27, 2012 by 4:00 pm**
