If you cast a vote for a candidate whose name is printed on the ballot, do not write that candidate's name on the write-in candidate line.</p> <p>5. To cast a write-in vote, darken the oval (●) to the left of the line provided and write in the candidate's name.</p> <p>6. If you make a mistake or want to change your vote, please return your ballot to a precinct election official and obtain a new one.
