

**Automatic Recount Board Meeting
of the November 5, 2013 General Election
Wayne Township Trustees, Loveland City Council Members
and Loveland City School District Board Members**

Chairman Tim Rudd called the meeting to order at 9:10 a.m. Dave Lane led the Pledge of Allegiance. Board Members present were Tim Rudd, Dave Lane and Paul Campbell. Also present were Judy Miller – Director, Mike Keeley – Deputy Director, and Becky Rudd – Clerk taking record. Rick Combs arrived at 9:59 a.m.

OTHER ATTENDEES: arrived after the meeting started-Observers: Dennis Elchlinger and Darin Hinnert-Observer appointed by Teresa Hinnert

Selection of Precincts to be Hand Counted for Verification:

Director Miller explained the procedures for the hand count.

Wayne Township Trustee – the amount to be hand counted was 84.1 votes.

(1,682 total votes X .05 = 84.1) The Board randomly selected Wayne Township B – 407 votes.

Loveland City Council – the amount to be hand counted was 69 votes.

(1,380 total votes X .05 = 69) The Board randomly selected Loveland City B – 977 votes.

Loveland City School District – the amount to be hand counted was 139.1 votes

(2,781 total votes X .05 = 139.1) The Board randomly selected Miami Township L1L – 305 votes.

2013-131 – Dave Lane made the motion to allow the staff to proceed with the hand count of the selected precincts. Paul Campbell seconded the motion. Upon roll call, all Members present voted “yes”.

Judy gave instructions to the Observers.

At 9:20 a.m. the Board went off the Record to proceed with the hand count.

At 9:59 a.m. the Board went back on the Record.

2013-132 – Paul Campbell made the motion to accept the Results of the Test Deck for the Recount. Dave Lane seconded the motion. Upon roll call, all Members present voted “yes”.

Board Member Combs arrived at 9:59 a.m.

At 9:59 a.m. the Board went off the Record to continue with the Recount.

At 10:55 a.m. the Board went back on the Record.

Judy advised the Board that the hand count was complete.

The hand count matched the computer count for Wayne Township B, Loveland City Council and Loveland City School District.

Per the Directive we will now run all of the ballots thru the 650 scanner.

2013-133 – Rick Combs made the motion to accept the Results of the Hand Count and run the rest of the ballots thru the scanner. Paul Campbell seconded the motion. Upon roll call, all Members voted “yes”.

The Board went back off the Record.
The Board went back on the Record.

Judy explained that all of the ballots had been run thru the scanner. She stated that there were no changes in the Wayne Township Trustee race or the Loveland City Council race. The declared winning candidates for Wayne Township are Harold Gosnickle and Warren Walker. There was a change in the Loveland City School Board race. The recount determined an additional vote for 3 candidates due to indeterminate marks, which were duplicated by the Board to allow for voter intent in precincts Miami Township Z and Goshen Township N.

2013-134 – Rick Combs made the motion to accept the Results of the Recount for Wayne Township Trustee, Loveland City Council Members and the Loveland City School District Board Members and report the results to the Ohio Secretary of State and the Hamilton County Board of Elections (which is the most populous County in the Loveland City Council and Loveland City School District races). Paul Campbell seconded the motion. Upon roll call, all Members voted “yes”.




